background checks. Clinical facilities may limit or prohibit students with positive drug screen results or criminal histories from participating in clinical experiences, thus making the student ineligible to continue in the program Students are responsible for all fees incurred with these checks and screenings.

Students enrolled should understand that the required clinical experience in various health care facilities may expose them to environmental hazards and infectious diseases including, but not limited to tuberculosis, hepatitis B, and HIV/AIDS.

#### **Licensure Requirement**

If an applicant has been convicted, had any adjudication withheld, or has been charged with the commission of a felony or misdemeanor, the applicant will need to get approval from the Florida Board of Dentistry to take the licensure examination upon completion of the Dental Hygiene Program.

#### **Cost of the Program**

The cost of the tuition and fees, textbooks, instruments and uniforms for the Dental Hygiene Program varies from year to year. Please refer to scf.edu/DentalHygiene for current information. Course fees include student malpractice insurance, required drug screening and laboratory supplies.

#### **Financial Aid**

#### What is a dental hygienist?

As a licensed professional, the dental hygienist promotes optimum oral health for individuals and groups of individuals through preventive education and clinical and therapeutic services.

#### Where are dental hygienists employed?

The Dental Hygiene Program prepares the student for employment as a dental health educator and clinician in a variety of settings including private dental practice, public health departments, institutional and research facilities, and public and private schools.

### What are the educational requirements for becoming a dental hygienist?

The course of study includes general academic studies, technical courses in dental hygiene concepts and procedures, clinical experiences in the dental hygiene clinic and community facilities, and community and public health education experiences. Integrated into the program is the dental "team concept" with inclusion of four-handed dentistry and those expanded dental functions that can be legally delegated to a dental hygienist in the state of Florida. Graduates of the Dental Hygiene Program will be awarded an Associate in Science degree in dental hygiene and are qualified to take the National Board Dental Hygiene Examination and Florida state licensing examination, both of which are required for licensure in Florida.

#### **Admission Requirements**

In addition to the admission requirements of the College, the following are requirements for admission to the Dental Hygiene Program:

- Earned grade point average (GPA) of 2.75 or better in ALL general education courses required by the program toward the degree and a minimum overall GPA of 2.0 to meet graduation requirements.
- 2. Satisfactory completion of any remedial course work needed to be eligible for college level courses. NOTE: Prerequisite courses may be required for ENC 1101 and the math courses. These prerequisites MUST be taken PRIOR to entry into the Dental Hygiene Program. Consult the course descriptions in the Catalog at scf.edu/Catalog for additional information.
- 3. Prerequisite courses must be completed with a grade of "C" or better by the end of the term prior to the application period in which you are applying. BSC 2085C Anatomy & Physiology I CHM 1020C Chemistry for Everyday Life (previously CHM 1022) or higher level Mathematics Choose from Area II, A.S. (MAC 1105 College Algebra OR STA 2023 Elementary Statistics preferred)
- **4.** A minimum grade of "C" is required in all courses applied toward the Dental Hygiene degree.
- 5. A completed application for the Dental Hygiene Program (A separate application is required for admission to the College.) One time application fee of \$20 must be submitted with the Dental Hygiene application.

Students are admitted to the Dental Hygiene Program once a year with classes beginning in the Summer term. This is a limited enrollment program. The Dental Hygiene Program consists of both classroom and clinical experiences. Completion of all or part of the general academic courses required for the degree does not guarantee acceptance into the program. However, priority is given to applicants who have completed the most required hours of coursework toward the degree by the end of the Fall term preceding the year for which the applicant is applying. If there are more qualified applicants than seats available in the program, the primary criteria for selection is the GPA of the general education courses required by the program. The secondary selection criteria is the overall college GPA. Applications are reviewed and the admission decision communicated to the student via SCF student email account. Students not accepted may reapply for Dental Hygiene admission the following year at no charge.

Upon acceptance, the following are required: Background checks; fingerprinting; CPR certification; and health and drug screenings to meet local health care agency regulations. Based on the results of these checks and screenings, students may become ineligible for program admission. Continuation in the program is based on acceptable results from random/ongoing screenings and
