## Apply

Apply at [www.scf.edu/admissions](http://www.scf.edu/admissions)

- >**Residency** if designated as a Non-Florida resident, a Waiver may be applied – see A Veteran Advisor.
- >**Official** final high school or GED transcript (submitted directly from the HS or GED location to SCF)
- >**Official** transcripts from previously attended colleges and **Military transcripts** (submitted directly from the institution/DDO to SCF) [Joint Service Transcripts](#) or [Community College of the Air Force](#)



## Orientation/Registration

- >**First time** in college students and **transfer** students must complete orientation prior to registering. [www.scf.edu/orientation](http://www.scf.edu/orientation) 941-752-5050
- Note: Testing holds could delay orientation.*
- >**Returning** students may register for classes directly at [MySCF](#)



## Test – Assessment & Testing Center

- Students may provide **ONE** of the following:
- >ACT, SAT or PERT scores taken within the last two years and/or
  - >Proof of successful completion of approved college readiness course(s) in math and/or reading and writing. *Note: Veterans, dependents and Active Duty military may be exempt from testing, if so, any remedial courses cannot be certified – see Veteran Services.*

## VA Benefits Application Process

- If applying for your educational benefits for the first time:
- >**Veterans** complete form **22-1990** at [vets.gov](http://vets.gov)
  - >**Dependents** complete **22-1990E** (33 Transfer Entitlements), or **22-5490** (Chapter 35) at <http://vabenefits.vba.va.gov/vonapp/>.
  - > Submit copy of your member 4 **DD-214** (Veterans), **Notice of Basic Eligibility** (NOBE for Reservists/Guard) or **Birth/Marriage Certificate** (Dependents) to a Veteran Advisor.
  - > Submit **Certificate of Eligibility** to a Veteran Advisor.



## VA Benefits Transfer Process

- For a **Change of Program** or **Place of Training** complete & Submit form to a Veteran Advisor or on Van-App.
- > **22-1995** (Veterans and 33 Transfer of Entitlement), or
  - > **22-5495** (35 Dependents).
  - > Submit copy of your member 4 **DD-214** (Veterans), **Notice of Basic Eligibility** (NOBE for Reservists/Guard) or **Birth/Marriage Certificate** (Dependents) to a Veteran Advisor.
  - > Submit **Certificate of Eligibility** to a Veteran Advisor.



## VA Educational Payments

- > Students must complete a **Request for Certification** form **each** semester they desire to use their benefits and to have the tuition deferment applied. These forms can be submitted online at [www.scf.edu/veterans](http://www.scf.edu/veterans).
- > All eligible veterans or dependents pursuing an education using VA or military education benefits are entitled to one 30 day or 60 day deferment for the payment of tuition and fees only (books and supplies **not** included)
- > Students who fail to pay their tuition by the deferment date will have a financial hold placed on their account, preventing them from signing up for classes and accessing SCF transcripts.
