- \*Beginning with 2022-2023 catalog year, prior to being awarded an associate in science (A.S.) degree, students entering an A.S. program are required to complete at least one core general education course (Category A) in each general education subject area. A grade of "C" or better shall be considered successful completion in all courses that are part of an associate in science (A.S.) degree. Students must complete 15 or more hours from Category A of the five areas listed in the Catalog. Please note ENC 1101 Written Communication I is a specific course that is designated in the Area I, Communications and is a requirement of this A.S. program and meets these requirements in this Area.
